Violence against women is punishable

The situation for those, who are concerned by domestic violence has distinctly improved because of the protection-against-violence law.

Police and justice have more means now to protect the victims. In case you were battered, kicked, threatened or even raped by your husband or friend the police has to bring a criminal charge against him.

The police can banish your husband or friend from the flat within a very short time. They can forbid him to stay in contact with you or take him into custody. The police can take up contact for you with the organisation "Women help Women". You can go to a women's refuge to protect yourself either alone or together with your children.

There you are safe from maltreatment. The colleagues there will support you by all further steps. Take all important documents with you, even those of the children:

- ID card/ passport
- bank account card
- health insurance card

At the advice centres (see overleaf) you'll find help and advice for your further decisions and also more information about the violence-protection-law.

You can apply for money for the advice service or for legal aid if you don't have the money for legal expenses or court fees. You can put in an application at the magistrates' court of your place of residence, either with the help of a lawyer or on your own.

You can obtain a judicial decision in order to get the common flat allocated (removal order), if necessary with a contact ban. For that you can also claim the costs for the services of a lawyer or you can take your case to court by yourself.

If available bring the following documents:

- ID card / passport
- tenancy agreement
- confirmation from the police about the charge and/or removal order
- a doctor's certificate in case you are hurt
