



## CORONA – Rules to follow, after returning home from a vacation

### After vacation, it is important to clarify...

Who is returning from vacation or any business trip in the next days or weeks during the COVID-19 pandemic, needs to follow these important instructions.

- It is important to pay attention to any **cold symptoms** and to clarify those at the Emergency Medical Services at Tel.: 116 117, your Family Doctor or the Health Department
- Inform yourself if the region that you have been to **is on the risk region list**. This list can be found on the homepage of the Robert-Koch-Institute [www.rki.de](http://www.rki.de).
- **Corona tests** are free of charge within the first 72 hours after your entry – please consult your doctor or the emergency medical services (Tel.: 116 117) for help.

### ...especially when returning from a risk region...

If your region was **on the risk list**, then you have specific obligations to follow.

- **Benefit of getting yourself tested directly after your entry in Germany. From 8th of August corona tests are mandatory for returnees from risk regions. Being tested 7 days after your return is even more significant; please arrange further tests if you are uncertain. Please consult your doctor or the emergency medical services (Tel.: 116 117) for help.**

- You have to directly **isolate yourself in a home Quarantine for 14 days**, where you are not allowed to have any visitors from outside of the household. It is also important to avoid any contact with other people. A regulation of the State of Hessen on Quarantine and more precise regulations can be viewed on [www.hessen.de](http://www.hessen.de).
- **You have to notify the Health Department of your return**, this can be done in the comfort of your home fast and easy over “CoroNetz” at [www.mkk.de](http://www.mkk.de) where you then look for “Kontaktformular” under “Sie wollen in die Bundesrepublik Deutschland einreisen?”.
- **Protective measures must be taken**, also from those who have not traveled in your household (for example, kids,

husband or wife).

- **It is forbidden for you or a member of your household to work or go to sensitive facilities (hospitals, schools, kindergartens, nursing homes, daycare facilities) until verified that you or a member of your household are not infected with the Corona-Virus.** Since July, household members are also to be registered with the following Name, Birthday, School and Work occupation..
- **Get an adequate laboratory test and get advice from a doctor.** It is the only way to clear up the situation for you and your household and the facilities in which you or members of your household are supervised, taught or employed.
